

ORGANIZATION OF A. A. U. COMPLETE

Meeting of Delegates Chose Board of Managers and Elected Officers.

Eight organizations which wished to join A. A. U. had delegates present at the meeting held at Lorrin Andrews' office yesterday afternoon at four o'clock, and besides there was a delegation from Punahou which came down to ask some questions, the answers to which they will report to their school today.

The permanent organization of the local branch was completed, the board of managers was elected, comprised of one man from each of the clubs represented, the board elected the three important officers, president, vice-president and secretary-treasurer, and then the meeting adjourned until Saturday at one o'clock, to meet at the same office.

The board of managers, upon motion of A. H. Ford, was voted to consist of one man from each of the clubs represented, thus making the board at present of eight members, and as other clubs joined each to have one member on the board until a maximum of fifteen was reached.

Each delegation present named one of its members for the board of managers and those were voted on as a whole board, as follows: Myrtle Club, John T. Soper; Healani Club, A. H. Tarleton; Outrigger Club, Lorrin Andrews; Trail and Mountain Club, G. S. Tuttle; Puunene, F. O. S. Bowen; Y. M. C. A., Paur Super; Boyer; Palama Settlement Club, W. and Grammar School Athletic League, C. T. Fitts.

According to the laws of the union the three important officers are to be selected by the board of managers, and as soon as this board was chosen it proceeded to select a president, vice-president and secretary-

treasurer.

During the preliminary stages of the meeting Lorrin Andrews was in the chair and Paul Super was temporary secretary-treasurer, receiving the credentials of the club delegates and the dues of \$7.50 from each.

It was proposed that Andrews be chosen president, but this gentleman positively refused to serve on account of too much private business, and so, after tendering him a vote of thanks, Tarleton proposed the name of G. S. Tuttle for president. There were no other nominations and M. Tuttle was elected unanimously.

He then took the chair and the name of A. H. Tarleton was proposed as vice-president and that gentleman unanimously elected.

There was considerable discussion before a secretary-treasurer was finally selected in the person of W. S. Bowen of Palama Settlement. This discussion arose over the question of professionals, it being held by some that Mr. Bowen and others who were athletic instructors could not belong to the union.

The matter was finally settled by electing Mr Bowen to the place and agreeing to refer this question to Secretary Sullivan at New York for an opinion.

It was expected that more clubs would be represented than were present at the meeting, but some do not understand what their standing would be should they play against professional teams, and other points, which as soon as they come around and get the necessary information will be perfectly clear to them and they will in all probability join the association.
