

# A. A. U. VOLLETS READY TO OPEN 1928 CAMPAIGN

## Complete Schedule of Series Is Announced; Firemen Favorites

All the eight teams entered in the 1928 race for the championship of the A. A. U. volleyball league report that their squads are in the best of shape, ready to kick off the lid next Tuesday night, May 8, at the Palama Settlement gymnasium, when a twinheader will be staged.

The opening clashes will bring the All-Around Chinese Athletes and the Nuuanu "Y" artists together in the first game at 7:30 o'clock and the Fire Department, last year champions, against the Outrigger Canoe sextet in the second fixture at 8:30 o'clock.

The other four teams, Kalihi, Central "Y," Palama Settlement and Iwilei will rest and take in the proceedings from the sidelines. These four teams, however, will swing into action Thursday at the Central "Y" court.

Fans and followers of A. A. U. volleyball teams are convinced that the Firemen slammers will again annex the title. They have shown lots of promise in practices and the team appears to be better than the 1927 model which won the title.

### Dark Horse

Palama Settlement is placed on the "dark horse" list. This is also true of the Nuuanu "Y" outfit. The A. C. A.s, Kalihis and Central "Y" players are not out of the running. Iwilei might pull the big surprise by trimming the rest of the gang. This is also true with the Outrigger team, which is reported to be exceptionally strong this year.

All Tuesday games are played at Palama Settlement, all Thursday games at Central "Y" and all Friday games at Nuuanu "Y." No admission is made.
