This majority, after a two hour disenssion of skirts last night, so voted. They voted their perfect neutrality in skirts attached to swimming clothes and disowned skitrs in the abstract by repudiating any official relationship between their organization and that of the Woman's Auxiliary, from whence arose the original objection to skirtless mermaids.

As finally passed, the resolution of the Outrigger members was:

"Be it resolved by the Outrigger Canoe Club that this club is not interested in the bathing suit controversy and that it is not officially connected with the Wo-

Expurgated Version

This was not the way the resolu-tion read in the beginning, when Os-wald Mayall first sprung it at last night's annual meeting at the Library of Hawaii. Mayall's resolution was wery much more to the point he wanted to make, but he was persuaded to permit the rough edges to be smoothed away by Messrs. Buttolph, Wall, Camp-bell, Lorrin Audrews and some others.

The discussion, that lasted fully two hours, both pertinent and extraneous to the subject, waxed warm. Finally the opposing camps affected a compromise and Acting-President Buttolph deleted the so-called objectional features and reworded the resolution as finally adopted. The vote for its adop-tion was large, but two "noes" being heard from the floor.

Chaperone Criticized

The board of directors was criticized for the appointment of the Woman's Auxiliary chaperone as the chaperone of the Outrigger Canoe Club and for permitting the chaperone to on women guests of the men's organization rules or order, procedure and regulations regarding what styles of bathing suits they should wear.

The general trend of the discussion was a slap-bang condemnation of the attempted regulation of bathing

Complained of Insults One speaker said that insulting notes were placed in some of the lockers, criticizing the suits worn by some wo-men. The chaperone, he said, had in-sulted several women through the unnecessary criticism she offered wearers of suits which did not meet her approval. One woman had been turned back four times and told that the bathing suits she had appeared in were not

"The chaperone was employed," said one speaker, "to look after the young girls and not dictate to women as old girts and not dictate to women as our as herself and as wise in their day what they should wear. The trouble has not been with the women guests of the Outrigger Canoe Club in the bathing suit controversy, but with women from the adjoining hotels and resi-

denees along the beach who frequent the strip in front of our club."

Another member was afraid the adoption of the resolution, which finally carried, would renew the controversy on the question and would cause sy of the question and would con-ill-feeling between the two clubs. On this score the spirit of moderation worked wonders and the most radical and rabid for the adoption of the original resolution finally gave way and

agreed to the compromise measure. The keynote of the whole discussion was that the Outrigger Canoe Club had never and was not now interested in what bathing costumes women wore on the beach so long as they suited the wearers, and that the two oguizawearers, and that the two og miza-tions were separate and apart and not officially connected, although they occupied adjacent premises and exchanged social courtesies.
