May I state, Mr. President, that many who wished you as the head of the Outrigger Club hoped and believed that your personality might and would bring about a pleasant and perfect understanding between the Outrigger Canoe Club abd the Women's Auxiliary. The time seems opportune for this, and would it be out of place for us to request the directors to give you personally an opportunity to bring about that consummation so devoutly to be wished for.

My dear Mr. Campbell,

Mr. John Guild made the suggestion that he withdraw his wife and daughter from the Women's Auxiliary, putting them perhaps at the end of the waiting list, so that room may be made for two wives or daughters of Outrigger Club members, for his wife and daughter will be away for two or three years. He said that he knew that Mr. J.P. Cooke would be willing to withdraw the ladies of his family, who would also be away for two or three years, and that there are probably a number of other men who have daughters going away to the Mainland to school, who would take similar action, if some arrangement could be made with the ladies of the Auxiliary.

There are many men in the club willing to do all in their power to assist in any way their fellow members in securing accommodation for the ladies of their families, but feel that to erect another building on the grounds--really starting another Women's Club--would be unfair to the Auxiliary, for they let us have the grounds on which our bath houses and small lanai now stand, with the tacit understanding that all of our differences were settled finally, and certainly,

if we are going to start another women's club, it would only be fair for us to let the women have their grounds back before we do so.

Mr. Guild stated to me the day before he sailed for the coast, that he intended writing to the Secretary of the Women's organization, making the offer mentioned in this letter. Whether he had time to do so before the sailing of the steamer, I do not know, but I trust that if you think this matter has any weight, that you will put it before your directors for their consideration.

To secure as members any persons who have been or are resident in any Pacific land or Island, willing to pay nominal local annual dues and subscribe to the following objects:

To assist in the advancement of Pacific Interests;

To establish in a central place a permanent tribunal where delegates from all Pacific lands and peoples may meet and discuss the advancement of their commercial interests and settle pending disputes without recourse to outside influences;

To promote in his own and in all other Pacific lands a feeling of fellowship among those resident there who are from the various Pacific lands or islands, or who have visited them;

To spread abroad around the Pacific a knowledge of all Pacific communities and to secure from each other and around the Pacific a better knowledge of the lands in and about the great ocean, and the objects, aims and ambitions of their respective peoples;

To aid in securing coöperation on the part of the many Pacific Governments in worthy objects looking toward the attraction from Europe and America of tourists, immigrants, business men, and all whose presence in Pacific lands will be a distinct gain to the common interests of all who live about the Pacific;

To take active part in any movement directed toward the betterment of each of the Pacific communities as a place of residence or a land to visit;

To keep alive a pride in the land in which we live as well as the land from which we came, and to do all we can to make both more worthy of that pride.

It is desired that local branches of the HANDS-AROUND-THE-PACIFIC ORGANIZATION be formed in the various Pacific communities, and correspondence from any association or individual interested in these matters is schicited by the central body in Honolulu. Many Pacific cities have already organized weekly get-together luncheon clubs affiliated with the movement. Is there one in your city?

The "Mid-Pacific Magazine," a highly illustrated monthly issued from Honolulu, publishes monthly interesting articles on the movement and from many Pacific lands.

RE - ACCOMMODATIONS FOR WORMEN

TRANSCRIPT OF SECRETARY'S NOTES OF ANNUAL MEETING. 7-29-16

/ . . . . . (While the ballots were being countea, matters of new business were taken up).

J.M.Riggs. "Mr. President, I want to introduce the following

"That the Directors of the Outrigger Canoe Club are hereby instructed to have erected at once on any unoccupied ground controlled by the Club a one story frame building to contain not less than eight dressing rooms, to be used by the Wives and Daughters of members in good standing of the Outrigger Canoe Club. Only such Wives and Daughters whose names are on the waiting list of the Womans Auxiliary of the Outrigger Club to have the privilege of using said dressing rooms. This privilege to cease immediately upon their becoming members of the Womans Auxiliary of the Outrigger Club."

R.L.Noggle. "I second that resolution."

the following resolution: -

- <u>G.Hutchinson</u>: " I don't see why this dressing room should be limited only to the wives and daughters of members, and I think we should take care of all the women on the Womens Auxiliary waiting list besides the wives and daughters of members of the Outrigger Club. Give the single men a chance to bring their sweethearts."
- S.D.Barnes: "This resolution has two defects; one is that it is too drastic, and the other is that it would be running an opposition club." After a little talk on the matter generally, Dr.Barnes moved that the words restricting the use of the dressing rooms to those on the waiting list be stricken out.
- H. P. Agee: "One of the resons why the Club elects a comparatively small Board of Directors to manage its affairs is that they can give time and deliberation to questions affecting the welfare of the Club. I don't like the idea of the Club ordering or instructing the Board on matters of this kind. I think it would be much better for us to recommend that the Board give this matter its serious consideration, and I put that as an amendment that the words "instructed" be stricken out and the word "recommended" be inserted instead."
- W.J.Coon: "I second the amendment. I don't believe the it would be possible for this Club to handle a matter of this kind off hand, and I don't think a building with only eight dressing rooms would answer the purpose anyway."

J.M.Riggs: "My resolution does not limit the number of rooms to eight. This matter has been before the Board for over six months now and nothing has been done. How much many more months do they want to consider it?"

- J.Stickney: "As one of the young members of the Club I take a great deal of interest in the out-door sports of the Club. It was a mens club in the first place and it should always remain such. We got this ground on the understanding that it would be used to promote the art of surf riding and outdoor sports. In the last regatta Mr.Center tried all he could to get enough boys to make up a crew but there wasn't enough boys here to do it. This Club primarily is a man's Club, but this question of women has been up before the Board and the Club manytimes before and it has always been decided against, and I don't see why it shouldn't be decided against again. I think this provision should be defeated about having a new addition for women."
- <u>G.H.Gere:</u> "We can't get very far without the women. The Outrigger Club owes a great deal to the women and I think Mr. Riggs is on the right track, and I think it would do away with a great de deal of dissatisfaction among the membership if we can provide for our women folks to come down here and enjoy the swimming. To have dressing rooms will go a long way towards relieving that dissatisfaction. I believe in the idea, and whether it is best as 'instructions' or 'request' I don't care, but something should be done to relieve this pressure."
- <u>G.H.Buttolph:</u> "I wish Mr. Riggs would make that in the form of a recommendation. It is a delicate subject, and if the resolution is passed as Mr. Riggs puts it, the dressing rooms will have to be built. There are several questions to be considered, and we ought to have at least double the number of dressing rooms. Don't wave the red rag in front of the women."

(Calls for question on the amendment)

H.P.Agee:

"My amendment is: -

"That the matter be referred to the Board and "That the Directors of the Outrigger Canoe Club "give their careful consideration to the question "of having erected at once', and the rest of the resolution as put by Mr. Riggs."

J.F.Child. "And refer back to the Club so that we **ERYXKNEW** can get some action. Giving it serious consideration don't mean anything.

- G.K.Larrison: "I am in against the motion as put by Mr.Riggs, but I am in favor of the amendment of Mr.Agee."
- J.M.Riggs: Spoke for several minutes in support of his original motion, calling attention to the fact that there was nothing in it that opposed the Womens Auxiliary; that it was not an

opposition club or anything of that kind, and expressing his belief that the Womens Auxiliaty would welcome the project as it would relieve them of a great deal of pressure on their waiting list.

On the amendment being put to a rising vote the result was: -

For the Amendment, ..... 50 Against the amendment, ..... 43

The question was then called for on the resulution as amended. President Tuttle read the resolution as amended and it was carried by a majority "aye" and "nay" vote.

DIRECTOR'S MEETINGS.

August 17,1916.

Capt.Center asks for erection of storehouse. Suggests building 12 x 25 - says can be erected at a cost of about \$100.

> L.C. Thompson moves:-"That the Captain be authorized to get estimates of the cost of the proposed storehouse and report at the next meeting of the Board." MotMion seconded by A.J.Porter and carried.

Capt. Center also asks that a workshop 20 x 36 be erected.

L.C. Thompson moves :-

"That the Captain be authorized to secure estimates of the cost of such a workshop as he needs and submit same, with his recommendation as to the location of the workshop, at the next meeting of the Board." Motion seconded by A.J.Porter and carried.

August 23,1916.

Center reports that storehouse and workshop will cost \$1000.00; \$800 for the workshop and \$200 for the storehouse.

Mr.Cooper authorized to get estimates of cost, and report later, on workshop, and shed.

Sept. 5, 1916.

Mr.Cooper submits plan and location for storehouse and workshop. Location and plan for storehouse approved. Matter of workshop deferged. Mr. Cooper requested to get estimate of cost of erecting storehouse.

(P.S. No authorization for ther erection of a storehouse has been made, and no appropriation made therefor, up to date.Oct.9)

#### Re - DIVING PLATFORM.

#### August 23,1916.

Captain Center reports diving platform badly in need of repair. Center authorized to ascertain cost of repairing same.

Sept.9,1916.

Center reports that John O'Neill offers to furnish all labor and metal material for putting the diving platform in good condition for the sum of \$100; the Club to furnish all necessary lumber. Center estimated cost of lumber at \$15.00. O'Neill offers to sell iron ladderfor \$25.00 extra.

On motion of G.H.Buttolph Capt.Center was authorized to enter into a contfact with John O'Beill for \$100.00 to furnish labor and metal material for repairing diving platform. Motion seconded by Ur.Cooper and carried.

October 4,1916. Captain reported that diving stage had been repaired and put in good order.



At the written request of twenty-five members of the Outrigger Cance Club, in accordance with Section 6 of the by-laws, I hereby call a special meeting of the Club, to be held in Cooke Hall, Y. M. C. A. Building, at eight o'clock sharp Tuesday evening October 24.

STOREHOUSE----I told you the other day that my impression was that the Board had made an appropriation for the erection of a storehouse for paddles, etc. where the surf-board lockers now are. At my request the Secretary has given me extracts from the minutes covering this question, and I find that I was mistaken; that the location and plan of the storehouse were approved, but that neither an authorization nor an appropriation for its erection has been made.

DIVING PLATFORM----As you know, I have recommended a number of times that the spring-board on the lower floor be changed to the opposite side. At present the depth of the water is about the same on both sides. Inasmuch as it would take very little labor to change the board from one side to the other, I should like to see it done now, and if when the water gets deeper it is found that there is a coral bottom making it dangerous to dive, the board could be changed back to its present location.

Another thing I think ought to be done is to put matting on all the boards on the lower floor the same as is on the spring-boards. Mr. Center

## **OUTRIGGER CLUB** AGAIN IS FACING **ITS OLD PROBLEM**

#### Organization is So Popular Its Waiting-List is Much Ampler Than Its Accommodations

Shall dressing room facilities be provided by the Outrigger Canoe Club on its grounds for the use of women guests of members?

With the mailing today by Secre-tary J. Ashman Beaven of the Outrigger Canoe Club to all members of no-tices of a special meeting to be held a week from tonight in Cooke hall, Y. M. C. A., there has come to a climax the question which has arisen every year for the last four years without being settled and which now threat-ens to stir the argentization to the form ens to stir the organization to its foundations.

This is whether or not the Outrigger shall take steps to erect dressing rooms for women relatives and guests of members-women who have been unable to gain admission to membership in the woman's auxiliary of the club owing to the long waiting list and the already overcrowded quarters of the auxiliary.

At the annual meeting in July this problem created the most emphatic discussion of any one matter considered. A percentage of the members favored the move, while others argued that for the club to go to such lengths would mean a radical change in its former policy. The matter was finally referred back to the board of directors for their earnest consideration.

Far from being killed by this move, the proposition has again come forward, a written request for a special meeting of the club having recently been signed by 25 members and sent to President H. B. Campbell, who was elected at the annual meeting while away on the mainland. A similar re-quest signed by four members of the board of directors has also been re-ceived by the president.

'As both requests call for action on the same general subject," says the notice of the special meeting mailed today to each member by Secretary Beaven, "it has been decided that one special meeting will comply with both requests.

"Therefore, in accordance with section 6 of the bylaws, President H. B. Campbell hereby caths a special meeting of the Outrigger Canoe Club, to be held in Cooke hall, Y. M. C. A. build-ing, at 8 o'clock sharp on Tuesday evening, October 24.



Those favoring the proposition say there are members of the Outrigger whose wives, daughters, mothers and sisters have been on the waiting list of the auxiliary for nearly two years without being admitted to membership and that if the auxiliary cannot help them it is up to the Outrigger to take such action as will relieve the situation.

### OUTRIGGER CLUB FREE TO ERECT MORE BUILDINGS

#### Secretary Beaven Tells How Women's Auxiliary Turned Down Consolidation

That the Outrigger Canoe Club has never made a promise to the Women's Auxiliary that it would provide accommodations for the women folk of its members, and offers made by the Outrigger to consolidate the two organizations on equal terms were rejected by the auxiliary in 1914 with the understanding that the question of consolidation should be definitely set aside, was stated today by Secretary J. Ashman Beaven of the Outrigger.

Beaven's statement was written by him for the Star-Bulletin to clear up misunderstandings as to the present status of the two organizations in view of the special meeting of the Outrigger called for Tuesday night at 8 o'clock in Cooke hall, Y. M. C. A., to discuss and take action on the proposition of erecting additional bath houses on the Outrigger's grounds to accommodate women guests of Outrigger members. The secretary's statement says:

Dates Back to 1912

"Never at any time has the Outrigger Canoe Club made such a promise, and the only excuse that the makers of that statement can have for making it is that back in August, 1912, when the women's auxiliary bathhouses were located on the Outrigger Canoe Club grounds, an agitation developed among Outrigger Club members for dressing-room accommodations for their women folk, who could not then be accommodated by the Women's Auxiliary.

ba

"At that time the Outrigger Club decided to erect the building, as the members desiring it had subscribed the necessary funds. Before the building could be erected the Women's Auxiliary offered to admit into their organization all the women relatives of members of the O. C. C. who at that time desired accommodations, provided the money subscribed was turned over to the auxiliary. Long List is Prepared

"The Outrigger Club accepted this offer and the money was paid over to them. Then followed some correspondence conveying to the Women's Auxiliary the names of the ladies to be admitted and between the time of the acceptance of the offer and the final settlement of the matter a number of additons were made to the list of names. The list, if I remember correctly, contained about 60 at first, and this was gradually increased, pending the settlement, to a total of 75. At the time this matter was closed (November, 1912) the directors of the Outrigger Club voted: "That no further requests be made to the auxiliary for the admission of anyone to membership in that organization.

"That from this date any application for membership in the auxiliary; even though a member of the family of some member of the Outrigger (lub should be made direct to the auxiliary, and take its proper position on their waiting list; our list of applications may therefore be considered closed from this time."

Offer to Consolidate Made

"About two years later, in April, 1914, to be precise, when conditions again became acute, there was a strong sentiment among the members of the Outrigger Canoa Club that the constantly recurring demand for bathing accommodations for the women folk of members should be remedied in some way, and after much discustion it was felt that an amalgamation or consolidation of the two organizations would settle the problem. "A special meeting of the club was

"A special meeting of the club was held in May, 1914, and an offer of consolidation on equal terms was made to the Women's Auxiliary, which offer was subsequently declined by the auxiliary. Just about this time the Women's Auxiliary secured a piece of land adjoining the Outrigger Canoe Club's premises, and during negotiations which followed between the two organizations covering an exchange of leases for part of the land acquired by the auxiliary for a portion of the Outrigger Club premises, a condition proposed by the auxiliary as part of the consideration governing the exchange of leases was: "That the status agreed upon shall be permanent.' Just what was meant by this was not clear to the Outrigger Club, but this was made plain in a letter dated October 12, 1914, written by Mrs. W. A. Wall, secretary of the auxiliary, in which it was sald: ""\* \* and it is also connected



# TO REMOVE WAHINE TABU REGULATION

Outrigger Club To Hold Special Meeting To Consider New Clause To Bylaws

The hotly debated question of whether or not the Outrigger Canoe Club shail extend its privileges to woman gnests of the members, and also whether or not the club shall erect upon its grounds a bathhouse for women guests, is again to come up before the members. Notice was issued yesterday by Secretary J. Ashman Beaven that the president of the club, H. B. Campbell, has issaed a call for a special meeting, to be held Tuesday, November 14 on the second floor of the Library of Hawan building to consider and act upon certain proposed amendments to the bytain proposed amendments to the by-laws and also upon a resolution provid-ing that the board of directors be au-thorized "to provide flressing room facilities on any ground controlled by the club, for the accommodation of female guests of the members" and make the necessary directors. female guests of the members'' and make the necessary charges, rules and regulations for the use and govern-ment of such dressing room facilities. The proposed amendments to the by-laws would throw the club open to women guests of the members without regard to relationship and would alpermanent women residents of the Islands to become guests of the club for from one to twelve months. Change Broadens Out

This proposed change is much broader than the one first proposed and which was defeated on a technicality at a special meeting held recently. At that time a member opposed to having a women's bathhouse on the club trounds interposed the objection that for the club at that special meeting to legislate on the question would be unconstitutional. President, Campboll held that the point of order was well taken. The result was that the special meeting adjourned, to convene again immediately as a cancus at which the subject was holly debated. Finally, by an overhelming vote, the club members present and represented by proxy went on record as in favor

Finally, by an overhelming vote, the club members present and represented by proxy went on record as in favor of erecting a women's bathhouse and admitting to the club privileges women guests of the members, irrespective of relationship.

men guests of the members, trespective of relationship. It was then discovered that, although women had for years been admitted as cuests of members, this was contrary to the bylaws. The proposed amendments to the bylaws are designed to overcome this prohibition.

## OUTRIGGER CLUB Votes to erect Dressing rooms

With 234 affirmative votes against eight native, members of the Outrigger Canoe Club at a special meeting Tuesday night in the Library of Hawaii building passed a resolution to extend club privileges and bathing accommodations to women guests of members. An attendance of 104 members was present. There were also 141 members represented by proxy.

Following is the resolution passed authorizing the directors to provide dressing room facilities for women guests:

"Be it resolved by the members of the Outrigger Canoe Club, in special meeting assembled this 14th day of November, that the board of directors be and it is hereby authorized and empowered to provide dressing room facilities, on any ground controlled by the club, for the accommodation of female guests of members; and be it further

"Resolved, that said board of directors be and it is hereby authorized to make such charges, rules and reguiations as it may deem proper and necessary for the use and government of said dressing rom facilities."

A proposed amendment providing for voting by mail was decisively defeated by 224 to 18. Several amendments to the bylaws were adopted by a vote of 227 to 13.

President H. B. Campbell announced that the next "Moonbeam Dance" will be given by the club for members and guests only the night of the next full moon, Saturday, December 9.

# GO AHEAD WILL ITS BATH-HOUSE

#### Members Vote By 213 to 38 to Accommodate Women Guests

By a vote of 213 to 38 members of the Outrigger Canoe Club last night voted as a caucus that it is their desire to have the board of directors erect as soon as possible additional bathing accommodations for women guests of members. They passed by an equally large majority 189 to 53, question 2, providing that the term "guests" shall be held to include all women guests irrespective of relationship.

Propositions three and four were rejected by a big vote. The third question, whether the term "guests" should be held to include only those wives, daughters, mothers and sisters of members whose names are now or may be on the waiting list of the Women's Auxiliary, but only while they remain on the waiting list, was turned down. Only 73 members voted for it, while 116 voted no. On the fourth proposition, whether the word "guests" should be held to include only the wives, daughters, mothers and sisters of members whe

On the fourth proposition, whether the word "guests" should be held to include only the wives, daughters, mothers and sisters of members, whether their names are on the auxiliary's waiting list or not, the members rejected the question almost unanimously. Only 6 voted for it, while 185 turned it down.

The meeting started shortly after 8 o'clock in Cooke hall, Y. M. C. A., and had been going only a few minutes when Guy H. Tuttle, former president of the Outrigger, gave the session a punctured tire. He rose to a point of order and by quoting the bylaws showed the meeting had been called in contravention to them and that any action taken by members would be filegal until the bylaws are amended to make women eligible as guests of the club. His contention was sustained by Attorney L. J. Warren and Judge P. L. Weaver. President H. B. Campbell, in the chair, sustained Tuttle and adjourned the meeting, reconvening it two seconds afterward as a caucus, after which the vote was taken.

#### WHO ELSE COMES FORWARD?

On Sunday Sergt. James A. Mitchell, C. A. C., lost his life at Kahala. This tragedy, like that of Miss Crichton, might have been averted by a beach patrol.

Nothing but unbelievable carelessness and indifference have allowed Honolulu to go all these years' without establishing adequate safeguards along the beaches. It is true that Waikiki is an unusually safe ocean-bathing beach but as the crowds of bathers grow into constant multitudes, the need for beach patrols becomes vital. The Outrigger Club is ready to do its share. What about the beach hotels, bathing-houses, public and private, boardinghouses and the city itself?

Attendance was the largest of any regular or special meeting in the club's history, according to Secretary J. Ashman Beaven. There were 143 members actually present, filling every seat in the hall. Including prox-

meeting will soon be called to amend the bylaws so as to admit women guests. The board of directors will then go ahead and arect the additional hath-house. The meeting ended at 10:50 last night.

At the close of voting the president announced there will be a series of moonlight dances, given every month by the club for members and guests. The first will be Saturday night, November 4.

The Women's Auxiliary came in for some bouquets and brickbats. G. H. Buttolph and Judge P. L. Weaver said the auxiliary is the best friend the club ever had, but Secretary Beaven read a communication from the auxiliary in which it declined to supervise the proposed women's bathhouse, the women's directorate declining to meet with the Outrigger directors to discuss the plan. J. Morton Riggs said the auxiliary has nothing to do with the question and the club should act as it sees fit.



Dear Mr. Campbell: -

Answering yours of the 22nd in reference to board locker No.111, I beg to say that locker No.111 was rented in 1915 to Mr W.R.McAllep, and I have no record of ever having assigned that locker to you.

For the past four years all lockers, whether board or clothes lockers, have been assigned by me, and those in charge of the commissary on the grounds have fully understood this, and, so far as I know, have invariably referred all applicants for lockers to me. If anyone on the grounds presumed that Mr.McAllep's locker was unassigned because no board was in it, and then assigned it to you without reference to me, they exceeded their duty and are due for a call-down.

In many cases members, in remitting dues, omit to include surfboard locker rent, and in these cases a notice similar to the one enclosed is attached to their membership cards when I mail them. If no answer is received within a reasonable time I then notify the caretaker to remove the board (or else set the key of the locker aside) so that the owner of the board will call upon the caretaker and will then be informed of the non-payment of rent.

On June 20th I sent a list of board lockers to Mr.Tuttle showing the name of the person to whom the board, if any, in a locker belonged. This list showed the names of the delinquents and also the names of ex-members of the Club who last rented the locker and the numbers of the lockers supposed to be vacant. With this list I sent instructions as follows:-

"If you find surfboards in any of the lockers supposed to be vacant, you can mark the board with the name of the owner. You will please take such boards out of the lockers and store them elsewhere pending further instructions from myself or the Board of Directors."

In this list was mentioned locker No.111, registered in the name of Mr.McAplep, but there was no suggestion that any board in 111 should be disturbed.

I remember that Mr.Center did tell me that a board belonging to you was being stored in someone else's locker, but I have no recollection as to what number was mentioned.

When dues became payable on July 1st, Mr.McAllep sent his remittance without board locker rent, and the usual notice was sent to hom. No reply having been received by the middle of September, I then reassigned No.111 to Mr. W.A.Ramsay and, follow-

ing my usual custom, gave instructions that if a board remained in the locker it should be taken out, marked with the owner's name and stored away.

When your remittance for dues was reported to me, rent

for one board locker only was included, and of course No.110, the locker previously registered in your name was reassigned to you for the current fiscal year.

I am sorry you have cause for complaint, and assure you that, as far as I am concerned, your interests would have been properly looked after had No.111 or any other locker been assigned to you through me. but I cannot answer for lockers assigned by club employes contrary to instructions.

While talking on this subject I might mention that I received many complaints of boards being stolen or lost. My own board has disappeared, nothwithstanding the fact that the key has always been in care of the commissary and no one in charge of the commissary has ever been authorized by me to give the key to anyone else.

As a matter of fact, the whole surfboard proposition needs improvement as it has been unsatisfactory for a long time past.

I believe the keys to the surfboard lockers should all be kept in the commissary; that keys should be handed to the memmer on the Club grounds when required, and that members should be required to return the key to the commissary before leaving the grounds. I believe that all locks, padlocks, and keys for lockers should be furnished by the Club, and that the practice o f individual members furnishing private padlocks and keys should be discouraged, if not forbiddan. The practice was starged on account of the very poor and cheap locks furnished by the Club in the first place. 'Twas poor economy, and good locks are always worth more than the difference in cost of poor ones. It should not be a difficult matter to locate your lost board if the Club caretaker has followed instructions.

#### DIVING PLATFORM.

This will confirm our conversation on this subject, to the effect that I have had a talk with Mr. Center and that he does not understand that he has any responsibility in connection with the platform other than arranging for the repairs which have recently been completed. In addition to this I recently suggested that he buy a newladder to replace the broken one, and that the broken one and that the broken ladder be repaired and kept in reserve for the time when the new ladder will need repairs. It is thoroughly understood that you as Chairman of the House Committee are in full charge of the diving platform and the rope running thereto. I think the suggestion of Mr. Center that the rope be taken in immediately on account of its weak condition is a good one; also that this rope be repaired and held in reserve and that a new rope be purchased and put in place.

#### LOCKERS.

As you know, there has been a great deal of criticism and complaint about clothes lockers and surf-board lockers during the Mr. Ehrhorn

last few years. Mr. Beaven has recently written me on this subject as follows:

"As a matter of fact, the whole surfboard proposition needs improvement as it has been unsatisfactory for a long time past.

"I believe the keys to the surfboard lockers should all be kept in the commissary; that keys should be handed to the member on the Club grounds when required, and that members should be required to return the key to the commissary before leaving the grounds. It occurs toome that theiclothes lockersland the surf-board lockers both belong properly in charge of the House Committee. The Secretary of course should always be kept informed of changes to enable him to keep his lists corrected. It seems to me that the simplest and most satisfactory way to assign these lockers and to dispose of the accasional petty and vexing questions arising about them is to have them entirely in the hands of the people on the grounds, who will work under your instructions. This might place a little more responsibility upon your shouldars but I believe the responsibility should rest there rather than the Secretary, who is burdened with excess work which does not really belong to him. I advance this suggestion to you for what you may find it to be worth. Yours very truly.

#### "VOTING BY MAIL.

"Section 11a. Any question which is a proper subject for ballot at any meeting of the Outrigger Canoe Club, including the election of officers mentioned in Section 12 of the Club's By-Laws, may, at the discretion of the Board of Directors, and/or shall, at the written request of 25 members of the Club, be referred to the entire membership of the Club for ballot, either of 25 members of the Club, be referred to the entire membership of the Club for ballot, either by mail or by the depositing of ballots at a balloting place designated by the Board of Direc-tors, or by both methods jointly, and the results of such referendum are and shall be accepted as formal vote of the members of the Club, and shall be as binding upon the Club and its officers as if the ballot in question were taken either by written or printed ballot, or oral vote at any annual or special meeting of the Club membership. "All such ballots shall be cast in two sealed envelopes, the outer one to be without iden-

"All such ballots shall be east in two scaled envelopes, the outer one to be without iden-tification marks to show the name of the member voting, and shall be delivered intact, as re-ceived, to a committee of tellers to be appointed by the President for the canvassing of said vote. The inner envelope, enclosing the ballot, shall bear the name of the member casting the ballot. The tellers shall check the name on this envelope to ascertain if it is from a member eligible to vote, and to prevent duplication. They shall then remove the ballots and destroy all these envelopes before the ballots are unfolded or inspected. 'After counting and verification of these ballots the tellers shall deliver them, with a statement of the results, signed by all the tellers, to the Board of Directors, who shall immediately announce to the membership of the Club the results of such ballot.

"Any portion or portions of the present By-Laws of the Club conflicting with, or which would appear to prevent the carrying out of the provisions of this amendment, are hereby repealed and declared to be void, insofar as they may or might interfere with the taking of a ballot by mail.'

#### 2. PROPOSED AMENDMENTS TO SECTIONS 4, 52, 57, 67, 68, AND 74.

#### Present By-Law.

Section 4. The membership of the Club shall be divided into four classes as follows:

1. Senior members, aged sixteen years and over.

2. Junior members, aged ten and under sixteen years. 3. Life. 4. Tempor

Temporary, transient residents of the Territory of Hawaii.

Section 52. Temporary residents of the Territory of Hawaii may, upon the applica-tion of any senior member to the Treasurer, be admitted to the privileges of the Club as the guest of such member for a term of from one to three months, subject to the approval of the Board of Directors. An extension of the limit of three months may be granted by unanimous vote of the Board of Directors.

Section 57. The dues of temporary members shall be Two (\$2.00) Dollars per month.

Section 67. Every member shall be entitled to entertain guests in the Club grounds, and to extend bathing and dressing-room privileges to not more than twelve guests each year.

Section 68. The name of every guest and that of the member introducing him shall in all cases be inscribed in the book provided by the Club for that purpose.

#### Proposed Amendment.

"Section 4. The membership of the Club shall be divided into three classes as follows:

"1. Senior members, aged sixteen years and over.

"2. Junior members, aged ten and under sixteen years. "3. Life."

It is proposed to repeal Sections 52, 57, 67, and 68, and substitute the following:

#### "GUESTS.

"Section 52. Every member shall be entitled to personally entertain male and female guests on the Club premises and shall be further entitled to extend twelve dressing-room and bathing privileges to guests during each fiscal year without charge. Any member who extends more than twelve dressing-room and bathing privileges to dressing-room and bathing privileges to guests in any fiscal year shall be required to pay such sum or sums as may from time to time be fixed by the Board of Directors for such excess of twelve said privileges. Any member may, upon application to and approval of a member of the Order and Entertainment Committee, be granted the further privilege of entertaining day or evenig parties of guests, including dressingroom and bathing accommodations, subject, however, to such charges, rules, and regulations as may from time to time be made or approved by the Board of Directors. The names of all guests to whom dressing-room and bathing privileges are extended by a member, together with the name of the member introducing them, shall be inscribed by the member in a book provided for that purpose.

#### AMENDMENTS TO BY-LAWS.

Section 74. These By-Laws may be anended at any annual or special meeting of the Club, provided that at least two (2) weeks' prior notice thereof shall be posted upon the Club premises by the Secretary, stating the substance of the amendment proposed. It shall require a vote of twothirds (2/3) of the members present at any meeting to amend the same. "The Treasurer, or such other officer as may be designated by the Board of Directors, may, upon the written application of any senior or life member, admit temporary male or female residents of the Island of Oahu to the dressing-room, bathing, and general privileges of the Club premises as the guest of such member for a term of from one to three months. Similar privileges may, upon like application, be granted to permanent female residents of the Island of Oahu for a term of from one to twelve months. All applications for guest privileges under this paragraph shall be made upon the form provided for that purpose and shall be signed by the member, and all guest privileges granted or issued by the Treasurer or other officer shall be subject to the subsequent approval of the Board of Directors. The term for which such privi-Directors. The term for which such privi-leges are first granted may be extended or renewed from time to time upon applica-tion to and approval of the Board of Di-rectors, and said Board shall at all times have the right to cancel or withdraw any privileges so granted, renewed or extended.''


At a meeting of the Board of Directors of the Women's Auxiliary of the Outrigger Canoe Club, held this day, it was voted that the following communication be made to you:-

You will doubtless be much interested in knowing that your Board of Directors has taken speedy action in carrying out the wishes of the Club in the matter of providing dressing room facilities for lady guests of members.

On November 14th the Club instructed the Board to provide these facilities. By November 21st the Board had prepared and approved the location, plans and specifications for the necessary building; had awarded the contract for the erection of the building; and adopted the following scale of charges for dressing room accommodations for guests of members.

- 1. For Visitors; temporary male or female residents of Oahu, \$2.00 per month;
- For Guests: Permanent female residents of Oahu, aged 10 years and over: 1 month \$1.00; 2 months \$2.00; 3 months \$2.50; 6 months \$4.00; 12 months \$6.00;
- For occasional guests, male or female: 12 dressing room privileges free of charge during each fiscal year, and for each such privilege in excess of twelve, 25¢;
- 4. For parties of 5 or more guests using dressing rooms between 7 a. m. and 7 p. m., 10¢ each person, with a minimum charge of \$1.00;
- 5. For parties of 5 or more guests using dressing rooms after 7 p. m., 15¢ each person, with a minimum charge of \$2.00.

The building contract calls for the completion of the building within 14 working days from November 23rd and, if the contractor fulfils his end of the agreement, the new dressing rooms will be ready for service by December 8th.

Your Order and Entertainment Committee has planned to hold a GRAND BUFFET DANCE and ENTERTAINMENT, with an abundance of light refreshments, on Saturday evening, December 9th, as a dual celebration of the opening of the Women's Dressing Rooms and the inauguration of this new branch of usefulness to be served by the Club. This is going to be a splendid affair and, of course, we want you to be there and to bring your friends along. The tickets are \$1.50 each, admitting lady and gentleman,—extra ladies will be charged for at 50¢ each. I enclose two tickets and if you want more I will be glad to send them, or you can secure additional tickets at the Club grounds or from any officer or committeeman of the Club. If you decide to use these tickets, please send the money for them to the Treasurer, or if you do not wish to keep them, or either of them, then return same to the Treasurer. Your Order and Entertainment Committee will understand that you are willing to pay for tickets not returned by December 8th.

I am sending you herewith an application blank for you to use if you have a lady to whom you would like a guest card issued.

The accompanying envelope, addressed to the Treasurer, can be used for the purpose of applying for a guest card, or for returning tickets or money to the Treasurer, or both.

RE DIVERTING OF APUAKEHAU STREAM: WAIKIKI RECLAMATION PROJECT.

In reply to your communication of December 4, 1916. requesting further information relative to the Waikiki Reclamation Project, I beg to inform you that we have on file in this office complete plans and specifications for the Reclamation of the First Unit and a layout of the entire district, showing the proposed scheme of reclamation, all of which data may be examined if you wish to call at this office.

It is not possible for me to state definitely at this time just when the Apuakehau Stream will be diverted, inasmuch as this depends upon the time of commencing of the reclamation of the First Unit and the rapidity with which payments are returned into the Revolving Fund from the owners of land comprising this unit. Should the Board of Health dondemn the stream bed as insanitary, it would be filled and the cost of filling charged to the adjacent property owners. Otherwise, the Government would have no authority to do this work except by legislative action.

Dear Mr. Ehrhorn:

At the dance given by the Order of the Eastern Star at the Outrigger Canoe Club on October 28, 1916, at which there were probably 150 persons dancing at one time, it was noticed that there was an appreciable swaying of the dancing pavilion in a mauka-makai direction. The point where thes was observed was at the makai-Diamond Head corner. This swaying did not appear to occur in the Ewa-Waikiki direction. Several to whom I called attention to this phenomena corroberated my observation.

An explanation of this swaying is that the sway bracing is inadequate in the mauka-makai direction. The dancing pavilion is connected on its longest side to the smoking lamai which materially stiffens it from swaying in that direction.

Although this swaying of the pavilion structure is not yet a serious matter, its continued use for large dances will in time weaken the post connections, and soon make it unsafe for large dances.

I suggest that 6 by 6 or 6 by 8 inch sway braces be inserted diagonally between the posts, from the concrete supports to the bottom of the knee braces, in the plane of the maukamakai bents, alternating the direction of the diagonals in alternate bents. This should stiffen the posts sufficiently, at a minimum cost of material and labor. This will also not interfere with the handling of outrigger canoes.

As the Club plans to give a series of large dances this winter and the pawilion will undoubtedly be in demand for large public dances also, it is recommended that this sway bracing be constructed at an early date.
