Dear Mr. Campbell,

Your letter of the twenty-fifth of November last was duly received and read at the Meeting of the Board of Directors of the Women's Auxiliary held on the fourteenth of December. Regret was expressed that the offer of exchanging back the properties subleased by each Club from the other had not been accepted, and the following resolution was unanimously passed:-

- RESOLVED: (a) That the Women's Auxiliary should again offer to surrender the Women's lanai premises with buildings and improvements in exchange for that portion of the Helumoa premises now under lease to the Men's Club, without buildings and improvements.
 - (b) That the Women's Auxiliary, in case this offer be promptly accepted should reimburse the Men's Club in the sum of \$1,000.00 (One thousand Dollars), that being the purchase price of the Helumoa cottage paid by the Men's Club at the time of the exchange of leases in December, 1914.

The Women's Auxiliary desires to emphasize the fact that all buildings and improvements revert to the Lessors at the expiration of the Helumoa lease in May, 1925. As that lease has three years less to run than the lease of the Outrigger Canoe Club premises from the Queen Emma Estate, the Men's Club would have three years longer use of those buildings at present situate on the Helumoa

premises should this exchange be made as now proposed. Therefore it would seem to be distinctly to the advantage of your Club to avail itself of the present opportunity to remove these buildings, the Bishop Estate having given permission in writing for their removal.

The Women's Auxiliary would say, with regard to the supports on the Ewa side of the Dancing Pavilion and the flight of stairs now situated on the Helumoa premises, that it is quite willing that the supports remain undisturbed, but would request that the stairs be placed elsewhere.

With the property released by the surrender of all rights of the Women's Auxiliary in the Outrigger Canoe Club premises, it would seem as though there should be little difficulty in finding room for the bathhouses and smoking lanai of the men. The Women's Auxiliary has every hope that the offers now made will be accepted by the Outrigger Canoe Club without delay, and that the necessary arrangements will be completed in a spirit of harmony.

I would ask you to present this matter to your Board of Directors at your earliest convenience.

Dear Mrs. Swanzy:

Before replying to your letter of January 11 proposing that our Clubs exchange back the pieces of land leased from each other. I have taken the time to talk with and get the views of a number of our members as well as directors.

At the meeting of our Board held January 16 the various aspects of the question were thoroughly discussed and the conclusion was reached that the proposed exchange would be disadvantageous to our Club.

I regret that I am not in a position to make a more favorable reply to your letter, and I wish to assure you that there exists among our directors and throughout our whole membership a very friendly feeling for the Women's Auxiliary. Any other sentiment, if it exists at all, is certainly confined to a very few individuals. I make this statement, after looking into the situation further, to confirm what I said at our conversation the other day, when you suggested that such might not be the case.

When considering this matter of the leases, our Board of Directors was influenced by a desire to do everything possible to meet your views. However, we were forced to the conclusion Mrs. F. M. Swanzy

we reached by two considerations:

(1) Two years ago the Helumoa beach frontage property seemed so desirable to us that we were willing to pay \$1,000.00 for it and go to the further expense and trouble of moving our buildings over to it. Now that we have become settled on it, we value it more than we did at first. Therefore, the original reasons for acquiring it now appeal to us as doubly strong ones for retaining it.

(2) To move over from our original building sites cost us over a thousand dollars, and to move back and make the necessary adjustments and do certain incidental construction work would cost us much more than that. The net result of our moving over and then moving back again would be a waste of several thousand dollars of the Club's funds.

I trust you will appreciate that, under these conditions, our Board of Directors could not see their way clear to accept the proposal.

Come and express your views even if you don't anticipate taking an active part in competitions. Those who do enter the class will need your moral support and it will help a whole lot if you show your interest by being present.

Members of the Board of Managers of the Hawaiian Association of the A. A. U. will be present to advise and help us.

Don't forget the date-Monday Evening, March 19th.

At last night's meeting of the Board of Directors it was voted that you write the Women's Auxiliary regarding the fence recently placed about the women's lanai and that you attach to your letter as indications of the feelings of our members two documents, viz .:

(1) A facetious, flippant and very ill-advised letter from E. Lamont to the Women's Auxiliary; (2) A letter from E. Lamont to our Board stating that if we did not take certain action a special meeting of the Club would be called for.

Those who voted for this motion were yourself and Messrs. Cooper, Thompson and Ehrhorn. Messrs. Center and Dease voted against it. Before the motion was put I spoke strongly against it. After it was carried I asked you to re-cord in your minutes that I protested very positively against this action being taken and that I considered it against the policy of the Club.

I wish to point out that

(1) We have no evidence that a considerable number of our members want the Board to take a serious stand on this fence matter:

(2) That, if our Board desires this fence removed or altered, the proper and gentlemanly way is to so advise the Women's Auxiliary and ascertain their attitude in the matter;

(3) That to send them the two letters in question can have no effect but to irritate and give offense.

(4) That in doing so we deliberately commit our selves to a policy of retaliation and friction between two Clubs whose best interests demand peace and harmony.

I am amazed that a Board representing over half a thousand of the best people in Honolulu could so far forget its dignity as to allow itself to be the instrument for passing on letters of such an irritating and unfriendly tone to another important organization domiciled on the same premises.

I am sure that such a method of broaching this question to the Women's Auxiliary would meet with the unqualified condemnation of an overwhelming majority of our members.


My object in writing you this letter is to ask you to defer sending this communication to the Women's Auxiliary for about two days.

I am sending a copy of this letter to each of the members of the Board in the hope that after mature consideration they may come to agree with me that we would be placing ourselves in a weak position by forwarding Mr. Lamont's letters. If a majority of the Board so desire, I purpose calling a special Board meeting at once to revoke the action already taken or consider the situation more carefully.

Although Mr. Lamont's last letter was dated March 10 and addressed to the President and Board, I had no knowledge of it till last night. In order that I may be thoroughly posted, may I ask you to let me have copies of his two letters (or the originals from which I can make copies) as soon as convenient.

House and Ground Rules

1. MAINTENANCE OF ORDER

(a) The Club Steward is in general charge of the Club premises and is authorized by the Order and Entertainment Committee to maintain order and to prevent disorderly or ungentlemanly conduct, including ball throwing, sand throwing, and surfing in front of Club, near shore, when any of these have become, or are likely to become, an annoyance to members or their guests.

(b) Members and their guests must not appear in improper bathing suits. (Top pieces or skirts must be worn outside of trunks and be of ample length.) 0-

(c) Members should understand that the Club Steward represents the officers of the Club and that any requests made by him shall be respected accordingly.

2. SERVICE

(a) The use of a gas stove, for quick meal purposes only may be had for a reasonable time, free of charge by members or their guests, by applying to the Steward or the person in charge of the kitchen.

(b) A servant is employed to prepare and clear tables, make and serve tea, do scullery work, and keep the kitchen and lanai in order. These services are performed free of charge between the hours of 7:30 a.m. and 7:30 p.m. He is not required to act as cook, cook's helper, or for table service, except as stated above.

(c) For service after 7:30 p.m., application should be made to the Steward. Rates are as follows: Ten cents for each person served, with a minimum of twenty-five cents.

(d) When service after 7:30 p.m., or for ten or more persons, is desired, arrangement should be made with the Steward at least twenty-four hours in advance.

(e) Tipping is prohibited.

3. USE OF DANCING PAVILION

(a) Application for the use of the dancing pavilion should be made to the Chairman of the Order and Entertainment Committee direct, or through any member of the Committee, or the Club Steward.

(b) The exclusive use of the Dancing Pavilion for an entertainment for which tickets are sold or an admission fee is charged, may be had on payment of thirty dollars. When the party is private, and no admission fee is charged, the price will be twenty dollars. These charges are payable to the Chairman of the Order and Entertainment Committee prior to the entertainment for which the Pavilion is rented. (c) The Dancing Pavilion may be used by members and their guests for dancing, free of cnarge, when not more than six couples of one party are dancing at any one time. Should more than six couples of one party be on the floor at one time a charge of two dollars for the first hour, or fraction thereof, and one dollar for each succeeding hour, or fraction thereof, will be made to the member giving the party.

(d) The Pavilions and lanais will be vacated and closed at 10:30 p.m., unless special arrangement has been made for use beyond that time.

(e) Persons smoking, or wearing bathing suits, will not be allowed on the Dancing Pavilion at any time.

4. CLUB EMBLEMS

Each member or guest will be required to wear the Club emblem on the breast of his or her bathing suit. These emblems will be supplied by the Club.

5. VEHICLES

Bicycles and motorcycles must be left at the place provided for same and must not be ridden on Club premises.

6. DOGS

Dogs are not allowed on the Club premises except on leash.

7. SERVICE CHITS

All commissary sales are for cash, except that members in bathing suits may make purchases by singing a Club chit which shall be redeemed in cash before the signer leaves the grounds; also, chits for service or for the dancing pavilion must be paid before the signer leaves the grounds.

8. Lost or found articles should be reported to, or left with the Club Steward.

9. Valuables should be left at the commissary for safe keeping.

10. WOMEN'S DRESSING ROOMS

(a) Children under ten years of age will be allowed the use of dressing rooms when accompanied by an adult guest.

(b) Ladies will please present guest cards to the Chaperon, and register their names, with date, at each visit.

11. Suggestions and complaints should be in writing and may be left with the Club Steward or any member of the Order and Entertainment Committee.

To the Members of the Outrigger Canoe Club.

Gentlemen:

I enclose herewith a new set of rules, which I hope will elicit your approval and co-operation.

In this letter I shall outline briefly the privileges of the members of this Club and supply certain information connected therewith.

The entire club premises are open to all members every day from early morning till ten thirty at night and later by special arrangments with the Order and Entertaiment Committee. This includes the use of the bath houses, kitchen, and all lanais. Moonlight swimming parties are encouraged. If you have never tried it, do so some calm evening and you will discover a new pleasure.

DANCING AND SMOKING LANAIS. As we take pride in our dancing floor, we wish to protect it by barring from that lanai bathing costumes, smoking, children's frolicking, etc. Dancing is in order at all times except Sundays. The smoking lanai was designed as a place where our men could lounge at their ease.

KITCHEN AND CEMENT LANAI. Members may bring lunches and warm them up in the kitchen free of charge. Tea will be furnished for the asking. The commissary is supposed to be non-profit making, and will carry on hand any provisions for which there is a demand. After a moonlight swim hot tea or cocoa will be found well worth the trouble of preparation.

SURF BOARD LOCKERS are provided at a charge of fifty cents a year for each board.

GUESTS. Any member is always privileged to bring one or more guests to the Club. Unless he has obtained a card for them, it is expected that he shall accompany them. There are no restrictions on the hospitality he may offer such guests except in the use of the bath houses, where there is a special schedule of charges, applying to both men and women guests, as follows:

(1) Without charge, a member may extend the bath house privilege to guests twelve times in one year. He must register with the Club steward each time. After the twelfth time, he must pay twentyfive cents each time.

(2) Any member may obtain guest cards for one or more guests for periods ranging from one month to one year. This privilege does not include male guests who are local residents. Written application should be made to the Club Treasurer for such a guest card.

For women guests, a special bath house has been erected, and this is in charge at all times of our chaperon, Mrs. J. D. Jay. A women's comfort or rest room, adjoining the cement or hau tree lanai, has been provided for our women guests. Please note that a guest card does not entitle its holder to entertain or offer the hospitality of the Club to others who are not members or guests.

CANOES. The Club owns fourteen canoes -- six of three or four passenger capacity, one for six passengers, three for eight passengers and four for ten or eleven passengers.

These cances are for the free use of members at all times. A member may take out any Club cance at any time. He must first sign for the cance and paddles in the cance book left with Sasaki. If desired, a professional steersman can be hired at the rate of fifty cents per hour per passenger.

In addition to the Club canoes, there are now on our grounds three canvas canoes and four Hawaiian canoes.

CARNIVAL FLOAT. The Outrigger Canoe Club entered a float in the Water Pageant. It represented a wave carrying two surf board riders, and took first prize. Captain Center shares the entire credit for this float with certain of our younger members who assisted him. They unselfishly devoted themselves to this work, facing many difficulties and finally getting their suits ruined in the oily waters.

Captain Center's assistants were: L. Andrews, H. Bonner, Ernest Cook, Edric Cook, H. Harvey, C. Lambert, J. H. Pratt, Jr., and S. Stacker.

MOONBEAM DANCES. Our next "moonbeam" dance will be held April 7. These dances have now become an established feature. They have been an unqualified success from the start. The sale of tickets is restricted to members of the men's and women's clubs -- for themselves and their guests.



EXTRACT FROM BY-LAWS

Section 53. All Club dues shall be paid to the Treasurer of the Club and shall be payable July 1 of each year for one year in advance.

Section 63. If the dues of any member shall remain unpaid on the 31st day of July in any year, the Treasurer shall forthwith give written notice to such member of such delinquency, and shall post the name of the said delinquent on the Bulletin Board of the Club for a period of two weeks. The Board of Directors may at its first meeting thereafter, on proof of such delinquency, declare the membership of the delinquent in the Club to be forfeited and cancelled. After such forfeiture the member shall have no interest in any property of the Club.

Section 64. In cases of cancellation of membership for non-payment of dues or otherwise, such persons may be admitted to membership again by the Board of Directors only upon the payment of the regular application fee.

Gentlemen: -

A fence has been placed around that part of the Outrigger Cance Club premises controlled by the Women's Auxiliary, and it is naturally to be presumed that it is placed there by the consent and authority of the management of the Women's Auxiliary.

Whilst it is the undoubted right of the Women's Auxiliary to erect and maintain this - or any other barrier they see fit. I can see no earthly reason for the exercise of this right other than the desire to exclude members of the Outrigger Canoe Club and their guests from entering the Women's lanai or stepping upon the land surrounding it.

There is a strong feeling among members of our club that we should assist the ladies of the Women's Auxiliary to enjoy the complete exclusiveness they so evidently desire, and to attain this end I venture to suggest that the Outrigger Cance Club complete the work the Women's Auxiliary have so kindly started by erecting a really effective fence, barrier, corral, pen, or whatever you like to call it. The present fence is of wires strung between posts and is only some three feet in height. We can peep thry or jump over this fence, and it awful possibility open to us. If this fence were, say nine feet high, of solid boards, barbed-wire topped, none but the most athletic or acrobatic of our members or guests would be able to embarrass the ladies of the W. a. with their presence Such a barrier could be erected on our grounds or glances. and it would be a gracious act on our part to relieve the W. A. treasury of the expense of this most effective aid to exclusiveness.

It is also the sense of many of our club members that we further relieve the W. A. of the annoyance and embarrassment of close proximity to the presence of ourselves and We have a beauthful dance pavilion overlooking the guests. ocean; a smoking lanai with a similar prespective perspective; a large and cool refreshment and lounging lanai for the entertainment of ourselves and friends at luncheon and supper parties a well equipped kitchen; a comfort room for our lady guests, and a very useful commissary store. We and our guests have hitherto presumed to enter upon and use these facilities of our club even at the same time and in the presence of the Women's Auxiliary. If the Board, thru its Order and Entertainment Committee or its House Committee - whichever has jurisdiction would notify all members of our Club to refrain from entering upon or using these facilities. I feel sure the members would gladly acquiesce as long as the Auxiliary ladies are made happier by the unrestricted and exclusive use of the several little conveniences mentioned, which have been made possible by our contributions and by the enthusiastic work of our officer members. On the other hand it might be more simple to bar the Auxiliary ladies from the use of these facilities unless especially invited and accompanied by a member of our club, but that would be contrary to the uniform courtesy which we have always extended the Women's Auxiliary, and might be construed as a retaliatory measure. But, gentlemen, two wrongs do not make a right, and I doubt if the members of the O. C. C. would stand for such a move.

You will notice that I have not included our bathhouses in the list of facilities which should be restricted to the use of the Auxiliary ladies: I feel that our members should reserve these for themselves and their guests. Neither have I suggested that our members should be excluded from the ocean, but I would gladly include this if we had the whole say as to who should and who should not use the heavenprovided facility which enables men to perform that exercise which is next to Godliness.

In order that the Women's Auxiliary may again become acquainted with the courtesy which has always characterized our dealings with them, I have taken upon myself to mail their directors a copy of this letter.

In this letter I am speaking on behalf of a considerable number of Outrigger Club members, whose signatures would be gladly forthcoming if you so desire.

Gentlemen: -

Following up my letter of February 28th referring to the fence placed around that part of the Outrigger Canoe Club premises controlled by the Women's Auxiliary; I am informed by your Secretary that at a meeting of the Board held on March 6th, my:- "letter was read and ordered placed on file." This, I take it, means that you do not intend taking any stepps in the matter.

If this is so, I must confess that I, and the other members who resent the placing of this fence perhaps more than I do, feel greatly disappointed. We were in hopes that the official representatives of the Club, its Board of Directors, would take care to make known to the Women's Auxiliary the keen resentment which a large portion of the club members feels at this latest cutting insult, and would take such action as might be necessary to induce the ladies to remove this fence, or carry their apparent desire for exclusiveness to its logical conclusion.

There has been no desire to force our presence, or that of our guests, on the women of the club next door. On the contrary, our members have always been most generous and courteous in granting to the Auxiliary ladies the unrestricted use of our lanais, pavilions, commissary and kitchen, and I am sure none has knowingly or intentionally said or done anything that would tend to hamper our neighbors in the fullest enjoyment of these facilities, not even when, as has frequently happened, the ladies have practically monopolized our lanai upon the occasion of many supper parties and social entertainments.

But, gentlemen, when the Auxiliary ladies reciprocate these courtesies with such a flagrant and uncalled-for slap in the face as the barring of ourselves and our guests from steppong within hailing distance of their landi by the erection of a fence which is so placed that our lady guests have to take a flying leapfrom the lagoon retaining wall in order to get to the ocean - or take the only alternative of parading in their bathing suits between the two lanais and listening to the sneering remarks of the members of the W.A.; when they so place this fence that our lady guests trip, stumble and fall over it, then, to my mind, they lose all right to further courtesy or consideration on our part.

Out of a desire not to handicap or embarrass you in handling this matter. I refrained from sending a copy of my former letter to the Women's Auxiliary, and I am tempted to regret now that I did not send it.

I now respectfully beg to request that you frame and enforce a rule excluding members of the Women's Auxiliary from any part of the Outrigger Canoe Club premises which they have no legal right to use, also from our lanais, pavilions, kitchen, commissary, bathhouses and dressing rooms, unless personally invited and personally accompanied by a member of the Outrigger Canoe Club.

If you feel any hesitancy about doing this and would prefer that a special meeting of the Club be called to take such action as it may deem proper. I will be glad to see that a petition calling for such a meeting is signed by the required number of members.

I want to assure you, gentlemen, that this matter will not be allowed to slide along without some positive action being taken, and I really believe that if the Board does not act the members will take the matter into their own hands with some possibly unpleasant results.

And again, when recently Captain Center informed the Board that the younger members of the Club were ready to organize a swimming and diving team, it was Mr. Beaven who promptly volunteered to and did render telling assistance to Captain Center and the boys in establishing themselves. He may be depended upon to give just as hearty support to this branch of the Club as he has to others.

Mr. Beaven's years of earnest devotion to the best interests of the Club certainly entitle him to your support for the presidency, and you may be sure that he will be ever on the alert to protect its interests.

Mr. G. H. Buttolph, who was elected Vice-President in January, 1915, has held that office ever since. Absolute fairness has always characterized his actions and his keen judgment, dignity, and sound common sense has made him a valuable and efficient officer. He has many times proven himself the balance-wheel

when complex questions have arisen, and should be retained. We hope Mr. Buttolph will be re-elected Vice-President.

Mr. Deverill is a well known and popular member of long standing, who has always taken a deep interest in the affairs of the Club. We believe the Club is fortunate in having secured his consent to accept the position of Secretary, and we confidently predict that he will prove an efficient successor to Mr. Beaven.

"Tommy" Thompson, who succeeded Mr. H. B. Campbell, when he resigned as Treasurer in May, 1916, has made an efficient and energetic officer. The funds of the Club have been carefully and well handled by him and he should be re-elected.

"Dad" Center's efficient captaincy of the Club; his popularity with the entire membership; his enthusiastic work in the development of surfing, swimming and diving, and his undoubted superiority in all branches of water sports, as well as his expert knowledge of canoes and canoeing, entitles him by all means to remain in the office which he has so adequately filled for years.

Mr. F. C. Mighton has accepted the nomination for Chairman of the House Committee, a position which calls for a great deal of personal attendance and hard work at the Club grounds. The mere fact that he is willing to assume this office is ample evidence of his hearty interest in Club matters. We gladly endorse Mr. Mighton for this office and pledge him our support.

Mr. Chas. E. King, for Chairman of the Order and Entertainment Committee, is one of the oldest members of the Club. Gentlomen:

The life of the club during the past year has been distinguished in three important respects.

One of these is the change made in our by-laws for the purpose of enabling our members to offer the club privileges, including bathing accommodations, to their guests of the gentler sex. This innovation has proved a popular one and is an undisputed success. There can be no question as to the policy of the club being definitely established in this matter.

A second characteristic of this year's club life has been the series of Moonbeam Dances given by the club under the auspices of the Order and Entertainment Committee. These affairs are now looked forward to as regular events, and, in my opinion, inspire in many members an additional interest in the club.

The third feature of our club life which has made itself especially evident has been the crystallization among our younger members of a desire for team work. Members Outrigger Canoe Club July 24 1917

More than ever before our young men and boys have come to appreciate their importance and responsibility as part of the club, and that any rational activity or requirements in their interest would meet with the hearty support of their older friends. It is altogether proper that they should participate in the management of the club. I anticipate that the wholesome energy radiating from this younger element will permeate the entire club membership to its benefit.

I hope in the not distant future to see dozens of our members at some athletic meet and shouting their enthusiastic encouragement to the contestants striving to keep our colours to the front.

It is entirely possible for the Outrigger Canoe Club to have one of the finest and most successful athletic organizations in the world.

Perhaps it is due to this new spirit among the boys, or perhaps the credit is due to our Order and Entertainment Committee, but the fact remains, and it has been the subject of frequent remark, that there has been a minimum of boisterousness and a greater control of exuberant spirits on the club premises than in previous years.

An episode of this year concerns our relationship with the Women's Auxilliary. Last November that organization proposed that we exchange back leases with them, Members Outrigger Canoe Club July 24 1917

taking over from them the Women's lanai and returning to th them the land on which our smoking lanai and bathhouses stand. This proposal was not accepted. Later, under date of January 11, 1917, the Women's Auxilliary made us a similar offer with the provision that this club should receive as additional consideration the sum of \$1.000.-.

In order that you may see just exactly how the club stood then, and stands now, in this connection, I quote from my letter to the Freaident of the Women's Auxilliary, dated January 22, 1917, as follows:

- At the meeting of our Board held January 16 the various aspects of the question were thoroly discussed and the conclusion was reached that the proposed exchange would be disadvantageous to our club.
- When considering this matter of the leases, our Board of Directors was influenced by a desire to do everything possible to meet your views. However, we were forced to the conclusion we reached by two considerations:
- 1) Two years ago the Helumoa beach frontage property seemed so desirable to us that we were willing to pay \$1,000.- for it and go to the further expense and trouble of moving our buildings

> over to it. Now that we have become settled on it, we value it more than we did at first. Therefore, the original reasons for acquiring it now appeal to us as doubly strong ones for retaining it.

- 2) To move over from our original building sites cost us over a thousand dollars, and to move back and make the necessary adjustments and do certain incidental construction work would cost us much more than that. The net result of our moving over and then moving back again would be a waste of several thousand dollars of the club's funds.
- I trust you will appreciate that, under these conditions, our Board of Directors could not see their way clear to accept the proposal. -----

My personal opinion on this subject is that our entire beach frontage is so essential to us that almost no consideration should induce us to give up a foot of it.

This year for the first time our Order and Entertainment Committee has come into its own. At my suggestion provision for such a committee was made in the present bylaws which were adopted a year and a half ago. This committee has worked in close co-operation with the House Committee. I wish to express my keen appreciation of the unselfish work which the heads of both these committees have done for the club. In addition to their own personal work they have made it pleasant and agreeable for the other members of their committees to co-operate with them, thus increasing the scope and effectiveness of their service.

REPORT OF THE CHAIRMAN OF THE HOUSE COMMITTEE

TO THE

35

BOARD OF DIRECTORS AND MEMBERS OF THE OUTRIGGER CANOE CLUB

The House Committee appreciates the assistance and support it has received from the members of the Club during the year and extends its thanks.

During the year necessary improvements in various ways were installed in the commissary, lanais with occassional repairs to bathhouses, showers, benches and other fixtures of the Club.

Three new benches have been purchased and additional chairs and tables furnished for the lanai. The roofs of all buildings have been thoroughly painted. A new life line with new floats was installed; these floats are arranged so as not to cut into the life line which was the great drawback in the past using square floats. The commissary has been equipped with new shelving, and a new soda fountain has been installed. A water coil has been fitted into the soda fountain so that ice cold water for drinking can now be had.

A bathhouse for the use of lady guests of members has been built during the year. It has been in much demand and only lacked the facilities of taking care of the suits and towels of those using it. So great a demand was made for this convenience that a new addition was built to the house within the last month into which over four hundred open suit boxes have been installed and a large drying yard has been added the full length of the building on the lagoon side. Two tubs for washing the suits and towels of the guests have been installed A Japanese woman caretaker has been engaged and will attend to the necessary work.

Much of the grounds around the lanai has been beautified by supplying plants and flowers in painted tubs, and the grass has been much improved by a dressing of soil and the use of fertilizer, giving the club a cheerful look which has pleased many members.

It had been the intention of the committee to start filling in part of the lagoon, and this was granted by the directors of the Club, but owing to some misunderstanding of the Waikiki reclamation scheme, in which it was understood was to take care of the lagoon, the matter remained an uncertanity until it was too late to procure the necessary filling material. The partial filling of the lagoon is an absolute necessity not only from a health standpoint, but also th give the Club a larger area to build and I recommend that the incoming Board of Birectors give this important matter serious consideration, cooperating if possible with the hotels.

In retiring from office as Chairman of the House Committee I wish to again thank the members for their cooperation and support, and I herewith take the opportunity to thank the gentlemen who acted with me on the House Committee.



Article X. Conditions of Competition. EXTRACT FROM CONSTITUTION OF A. A. U

1. No person shall be eligible to compete in any athletic meeting, game or entertainment given or sanctioned by this Union who has (1) received or competed for compensation or reward, in any form, for the display, exercise or example of his skill in or knowledge of any athletic exercise, or for rendering personal service of any kind to any athletic organization, or for becoming or continuing a member of any athletic organization, or received or accepted any prize or reward for an exhibition, or otherwise than in a recognized competition; or (2) has entered any competition under a name other than his own, or from a club of which he was not at that time a member in good standing; or (3) has knowingly entered any competition open to any professional or professionals, or has knowingly competed with any professional for any prize or token; or (4) has issued or allowed to be issued in his behalf any challenge to compete against any professional, or for money, or (5) has pawned, bartered or sold any prize won in athletic competition, or (6) is not a registered athlete. Nor shall any person residing within the territory of any active member of this Union be eligible to compete for or to enter any competition as a member of any club in the territory of any other active member of this Union, unless he shall have been elected to membership in such club prior to April 1, 1891.

A student attending a university, college, school or other educational institution may consider such institution his residence for the purpose of registration to represent such institution in competition. Such student during the period between the close and the opening of the scholastic year may transfer his registration to a club or other organization belonging to an active or allied member of this Union, located in the district of his actual residence, which for this purpose shall be the residence of his parents or guardian if he be a minor, or his last place of abode before entering his educational institution if he be an adult, and upon the opening of the scholastic year he may be retransferred to his educational institution.

2. No one shall be eligible to compete in any athletic meeting, games or entertainment given or sanctioned by this Union, unless he shall be a duly registered athlete and a member of the organization from which he enters; nor shall any member of any club in this Union, or any club in any district of this Union, be allowed to compete as a representative of such club in case he has within one year competed as a member of any other club than in this Union, "unless he has secured permission to do so from the Registration Committee, of the district in which he resides, as hereinafter provided, or from the National Registration Committee, upon showing good cause therefor," or unless such other club shall have disbanded or practically ceased to exist; provided that the requirements of this section shall not apply to any athletic meeting, games, or entertainment, the entries for which are confined to the club or organization giving such entertainment or meeting.

No person shall be eligible to compete for or enter any competition as a member of any club in the territory of

any active member of this Union unless he shall have resided within the territory of said active member at least four months previous to entering for competition; nor shall any person be eligible to enter or compete in any district championship meeting unless he shall have been a bona fide resident of such district for at least six months prior to the holding of such championship meeting. These restrictions shall not apply to an undergraduate when competing for any college belonging to an allied body.

No person shall be eligible to compete in a championship meeting of more than one district in one year.

3. No prizes shall be given by any individual, club, committee or association, or competed for or accepted by any athlete, except suitably inscribed wreaths, diplomas, banners, badges, medals, timepieces and mantle ornaments, or suitably inscribed articles of jewelry, silverware, table or toile service, unless authorized by the Registration Committee, and said prizes shall not exceed the cost of \$35 for first, \$20 for second, and \$10 for third prize, unless by special permission challenge trophies or other similar prizes are authorized by the Registration Committee and a record kept of such authorization. Suitable team and individual prizes may be awarded for team competitions in a single specialty.

No more than three prizes in all shall be given in any event or competition, except in running or walking races of five miles or over, and in swimming races of one mile or over (counting a team prize, allowed as above, as one prize, unless by special authority of the Registration Committee.

4. The prohibitions of this article shall not apply to tokens or prizes (other than money), composed in whole or in part of metal, and bearing inscriptions denoting the event or contest, in any case where such tokens or prizes shall have been given or sanctioned by this Union, or any of its members, or prior to the formation of this Union, by any recognized amateur organization; provided, that if any person shall, at any time after April 1, 1891, sell, pledge or exchange for any other thing, any such token or prize, he shall thereafter be ineligible, and shall likewise be ineligible if at the time of the competition or entry therefor he be disqualified or under suspension by this Union, or any of its members, or any organization allied with or approved by it.

5. Persons not debarred by any of the foregoing provisions of this Article, or who, having become ineligible by violation thereof, or of any heretofore recognized rule of amateur standing, have been duly reinstated, and shall, in other and all respects, conform to the rules and regulations of this Union and its members, will be deemed by this Union and by its members amateurs.

6. The term "any athletic exercise," as used in the first section of this Article, shall be held to include such sports or exercises, athletic in form or substance, as the Board of Governors may determine.

any active member of this Union unless he shall have resided within the territory of said active member at least four months previous to entering for competition; nor shall any person be eligible to enter or compete in any district championship meeting unless he shall have been a bona fide resident of such district for at least six months prior to the holding of such championship meeting. These restrictions shall not apply to an undergraduate when competing for any college belonging to an allied body.

No person shall be eligible to compete in a championship meeting of more than one district in one year.

3. No prizes shall be given by any individual, club, committee or association, or competed for or accepted by any athlete, except suitably inscribed wreaths, diplomas, banners, badges, medals, timepieces and mantle ornaments, or suitably inscribed articles of jewelry, silverware, table or toile service, unless authorized by the Registration Committee, and said prizes shall not exceed the cost of \$35 for first, \$20 for second, and \$10 for third prize, unless by special permission challenge trophies or other similar prizes are authorized by the Registration Committee and a record kept of such authorization. Suitable team and individual prizes may be awarded for team competitions in a single specialty.

No more than three prizes in all shall be given in any event or competition, except in running or walking races of five miles or over, and in swimming races of one mile or over (counting a team prize, allowed as above, as one prize, unless by special authority of the Registration Committee.

4. The prohibitions of this article shall not apply to tokens or prizes (other than money), composed in whole or in part of metal, and bearing inscriptions denoting the event or contest, in any case where such tokens or prizes shall have been given or sanctioned by this Union, or any of its members, or prior to the formation of this Union, by any recognized amateur organization; provided, that if any person shall, at any time after April 1, 1891, sell, pledge or exchange for any other thing, any such token or prize, he shall thereafter be ineligible, and shall likewise be ineligible if at the time of the competition or entry therefor he be disqualified or under suspension by this Union, or any of its members, or any organization allied with or approved by it.

5. Persons not debarred by any of the foregoing provisions of this Article, or who, having become ineligible by violation thereof, or of any heretofore recognized rule of amateur standing, have been duly reinstated, and shall, in other and all respects, conform to the rules and regulations of this Union and its members, will be deemed by this Union and by its members amateurs.

6. The term "any athletic exercise," as used in the first section of this Article, shall be held to include such sports or exercises, athletic in form or substance, as the Board of Governors may determine.

My question is: May Duke Zahanamoka swim for the Outrigger Canoe Club in the coming Meet? Your letter of yesterday says neither yes nor no. You are familiar with all the data in the case. In view of the delay in getting this question answered so far and of the prominence of the swimmer, and of the uncertainty cast on the case in this morning's paper so far as one day of the Meet is concerned, may I ask you for an immediate and categorically answer to my question above put? Dear Sir:

In accordance with your telephone request, I have interviewed both Mr. Young and Mr. von Hamm in regard to the property under their control at Waikiki, directly adjoining the Outrigger Club on the Waikiki side.

I understand from them in substance the following:

They hold control of this land under lease from the Bishop Estate.

At the request of the Hui Nalus they are going to allow the erection of a cluthouse on this land near the beach directly adjoining the Outrigger Club's property.

They will not charge any rent to the Hui Nalus and they will not make any definite lease, thereby keeping the property under their control.

They consider that the Hui Nalu members have been of great service to them and the public in general in the protection of the lives of bathers.

For a long time they have allowed certain members of the Hui Nalus the free use of the Moana Hotel bath houses.

They claim that the Hui Nalus are occupying the beach at this point constantly, and feel that if some of the men interested in the Hui Nalus can finance the erection of a suitable building for the use of the members, it is right and proper that the Hui Nalu should receive this consideration.

By exercising control of the uses for which said building will be used, both Mr. Young and Mr. von Hamm feel that there cannot and will not be anything objectionable to the Outrigger Club by their permitting the Hui Nalu the opportunity of the use of a building, instead of the beach only.

I understand that both Mr. Harold Castle and Mr. Alfred Castle are members of the Hui Nalus and are both interested in the carrying out of this proposed plan, and would suggest that you get in touch with them and take the matter up and see if it is not possible to have this plan go through (assuming that it is going to be carried out) without disagneeable feeling on either side.
