moters realize that they cannot hope to stage a fight show every week in competition to football. Ring shows are being staged on the other islands as usual. There was one on Maui Saturday night, which makes it look as though someone had his fingers crossed when there was talk of suspending all boxing operations in the territory.

Since the petition was drawn up, it has been shown that some of the items mentioned are already in the books. There is one of the petitioned items that will probably never be granted—and that is the one about posting certain bonds and certified checks. That is a protection every fighter and manager should insist on being continued.

Also, if it reaches the point where boxing control passes from the hands of the legally appointed commission into the hands of the promoters, then it is time to abolish boxing altogether.

J. R. Farrington, retiring president, gave the first annual report, that of the president, and declared that the Hawaiian Association of the A. A. U. had enjoyed a most successful year. Chase, as assistant treasurer, in handling the finances of the organization.
