

HUI NALU PADDLERS WIN ANNUAL CANOE REGATTA

Large Crowd Sees Races On Ala Wai Canal—Kamaaina Beachcombers' Hui Sponsors Program
—Victors Annex 3 Races

Hui Nalu won the annual canoe paddling championship from Outrigger by winning three out of five races on the Ala Wai on Kamehameha Day.

A large crowd witnessed the races which were sponsored by the Kamaaina Beachcombers' Hui.

Hui Nalu won the senior six event which was the blue ribbon race over a one-mile course in the time of 7 minutes 31.3 seconds. The crew was composed of J. Davis, J. Dickson, D. Aona, Ah Kong Pang, Wilfred Paul and J. Insberg. Outrigger entered two crews.

The Hui Nalus also annexed the junior six and senior four paddle events in the time of 8:03.4 8:36.5, respectively. The junior crew was made up of A. Love, D. Kalakaua, Z. Roski, C. Boyd, P. Silva, and J. Kaaua, while J. Davis, J. Dickson, W. Paul, and J. Insberg formed the senior four.
