

KA MOI IS VICTORIOUS IN SECOND CANOE RACE

Lead Sailing Series With 20 Points—Beats 'U Telling Me' By 30 Seconds in Compet Off Waikiki

Sailing a six-mile course off Waikiki in one hour and 14 minutes, the Waikiki Beach Patrol's "Ka Moi," skippered by Sally Hale, finished a bare 30 seconds ahead of John Ernstberg's "U Telling Me," in the second heat of the Outrigger Canoe sailing series for the Royal Hawaiian trophy. John D. Kaupiko's "Nukunuku" placed third, coming in 1½ minutes later followed by Gordon Fischer's "Hoonau" and Charlie Amalu's "Keeaumoku."

Increase Lead Steadily

Sally Hale's crew, sailing a beautiful race, steadily increased their lead from the first buoy on, and reached the beach seven minutes ahead of the "U Telling Me" which had a 6½ minute handicap. By winning this race the "Ka Moi" copped the beautiful Eastman Kodak trophy.

This victory gives the Beach Patrol entry ten more points toward the Royal Hawaiian Hotel trophy grand prize.

Following today's race, the canoes' standings are as follows: First, "Ka Moi," Waikiki Beach Patrol with 20 points. Second, a three-way tie among John Ernstberg's "U Telling Me," Kaupiko's "Nukunuku" and Gordon Fischer's "Hoonau," each with 12 points. Third place, "Keeaumoku," Charlie Amalu, three points.

Toots Minvielle's "Toots II" and Doris Duke Cromwell's "Lahilahi" failed to finish.

Wylie Mather's cabin cruiser was again on duty as committee boat with Jack Bowden and Tommy Kearns assisting as judges.
